5.0 Age Limit
(As on 01/01/2025)

(i) The candidates must have attained the age 21 years and must not have crossed the age of 40 years on 01-01-2025 i.e. they must have not been born earlier than 02nd January, 1985 and not later than 01st January, 2004.

(ii) Relaxation in upper Age Limit: -

- a) Upper age limit shall be greater by five years for candidates belonging to Scheduled castes of U.P., Scheduled Tribes of U.P., Other Backward Classes of U.P.
- b) Upper age limit shall be greater by fifteen years for persons with disabilities (PH) of U.P.
- c) Upper age limit shall also be greater by three years + Period of service (in Years) rendered in Army for the Emergency Commissioned officers/Short Service Commissioned Officers/ Ex-Army Personnel of U.P.

(iii) The age of superannuation in UPSBC Ltd is as per U.P Government order.

6.0 Reservation

- (i) The reservation for Scheduled Castes of U.P./Scheduled Tribes of U.P./ Economically weaker Sections candidates of U.P./ Other Backward classes candidates of U.P. shall be admissible in accordance with the provisions of relevant Govt. Rules. Similarly reservation for horizontal categories as Dependents of Freedom Fighters of U.P., Female Candidates, Ex-servicemen of U.P., and P.H. of U.P. shall be permissible as per rules.

In case of the women candidates, the caste certificate issued from her father side only will be treated valid.
- (iv) The Income and Asset Certificate shall be valid for the financial year 2024-25 in case of EWS candidates.
- (v) Candidate claiming reservation/Age relaxation in more than one category will be entitled to only one concession, whichever is more beneficial to them.
