INSTRUCTION FOR THE CANDIDATE

- 1. The application forms received incomplete or not properly filled in by the student of his parents/ guardians or received after the prescribed date shall not be entertained and rejected forthwith any notice. The candidate should therefore, ensure in his/her own interest that application forms complete in all respect reaches the Director, School Education Haryana, Panchkula well in advance before the prescribed date, otherwise his/her case will be rejected and scholarship will be awarded to the next eligible candidate without any further notice.
- 2. The students whose parents/guardians belong or hold any landed or immovable property in the Rural Area of the Haryana State, but actually reside o the Urban Area on Account of Service/Business etc. are not eligible for the award of a Rural Area Merit Scholarship. This condition is also applicable to the Children of Government or non Govt. employees or defence personal etc. The students whose father or mother or guardian is not actually residing at present in the Rural Area of the State, are also not eligible for award of Rural Area of the State.
- The Certificate of residence and that the indigence must be on the prescribed form appended at the end of the application and form the authorities indicted therein.
- The application may please be filled in neatly ad legibly.
- Any change in the address of course class or institution of study must be intimated to the Director School Education, Haryana, Panchkula immediately.
- The scholarship is liable to be cancelled in any information supplied in the application form/declaration/ certificate is later on found to be incorrect or the student becomes or is found ineligible on any other ground.
- 7. The application form complete in all respects must reach the Director, School Education, Haryana, Panchkula through the Head of the institution joined and duly recommended before
